SUBJECT: SB 1327 Reporting of the Severance of Attendance of Individuals with Exceptional Needs for 2020-

2021

Your assistance is requested in meeting the mandates of Education Code (EC) 48203, SB 1327, which requires school districts and private schools to report to the county superintendent the severance, expulsion, exclusion, exemption, transfer, or suspension beyond 10 school days of students served under IDEA or Section 504.

The county superintendent or designee is to examine the reports and draw to the attention of the county board and local boards any cases in which the interests of the child or the welfare of the state may need further examination.

The Division of Student Support Services staff will continue to work with parents and school districts discussing attendance alternatives for students, including IDEA and Section 504 identified students. As we are made aware of possible concerns from the data, we can follow-up with the local school district and the parent to ensure due process and examine possible violations of Section 504 or the IEP processes.

In order to collect the data for 2020-2021 to report to the county superintendent and the Board, as well as the local boards, local school districts must continue to complete the electronic survey for each student on an **ongoing basis throughout the year** at <a href="https://www.surveymonkey.com/r/D5VD5GD">https://www.surveymonkey.com/r/D5VD5GD</a>. We have also included the corresponding CALPADS data reporting codes in the survey. The data for 2020-2021 is due by July 2, 2021.

# **Implementation and Statute**

## **Implementation**

- As reports are received from school districts electronically, the Division of Student Support Services staff will immediately examine the data and contact districts and parents about concerns as appropriate, on an ongoing basis.
- Note that Special Education personnel already report some of this information for CALPADS (See below). The corresponding codes and information for this reporting system is noted in the SB 1327 electronic survey.

#### Statute

Education Code (EC) Section 48203. (a) The superintendent of a school district and the principal of a private school in each county shall, upon the severance of attendance or the denial of admission of any child who is an individual with exceptional needs, as that term is defined in Section 56026, or who is a qualified handicapped person, as that term is defined in regulations promulgated by the United States Department of Education pursuant to Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. Sec. 794), but who is otherwise subject to the compulsory education laws of California, report the severance, expulsion, exclusion, exemption, transfer, or suspension beyond 10 schooldays to the county superintendent of schools. The report shall include names, ages, last known address, and the reason for the severance, expulsion, exclusion, exemption, transfer, or suspension. (b) It is the duty of the county superintendent to examine those reports and draw to the attention of the county board of education and governing board of a school district any cases in which the interests of the child or the welfare of the state may need further examination. (c) After a preliminary study of available information in cases referred to it, the county board of education may, on its own action, hold hearings on those cases in the manner provided in Section 48914 and with the same powers of final decision as therein provided.

### California Department of Education (CDE) Reporting Requirement

# Other Reporting Systems

CALPADS (California Longitudinal Pupil Achievement Data System) is the foundation of California's K-12 education data system, comprising student demographic, program participation, grade level, enrollment, course enrollment and completion, discipline, and statewide assessment data. The student-level, longitudinal data in CALPADS enables the facilitation of program evaluation, the assessment of student achievement over time, the calculation of more accurate dropout and graduation rates, the efficient creation of reports to meet state and federal reporting requirements, and the ability to respond to relevant questions. CALPADS provides local educational agencies (LEAs) with access to longitudinal data and reports on their own students, and it gives LEAs immediate access to information on new students, enabling the LEAs to place students appropriately and to determine whether any assessments are necessary. <a href="mailto:calpads@cde.ca.gov">calpads@cde.ca.gov</a> (916) 324-6738.
