SUBJECT: Master Calendar of Financial Reports Due for 2020-21

The attached calendar (Attachment No. 1) includes approximate due dates intended to help local educational agency administration and staff prepare and submit 2020-21 financial reports to the Los Angeles County Office of Education (LACOE) in a timely manner. LACOE will issue separate bulletins throughout the year, indicating the actual due dates, and any additional instructions needed to prepare these reports.

#### AMENDMENTS TO CURRENT YEAR REPORTS SUBMITTED

If you discover an error in a report already submitted to LACOE or to the California Department of Education (CDE) during the apportionment processing period, but prior to the certification of the apportionment, please:

- telephone the LACOE contact person,
- explain the nature of the error, and
- submit the correction in writing, with a letter of explanation.

This is especially critical for attendance reports, which may be adjusted because of findings by the district's independent auditor, the CDE, the California Department of Finance, the State Controller's Office, employees of LACOE, or reports by the public. Please refer to the specific report instructions for guidance on how to submit revisions for the reports. LACOE staff will submit the revised reports to the CDE, and the CDE will determine if the revision will affect the district's State aid. If processing time permits, the correction will be included in the applicable apportionment. If it is not possible to make such a correction before certification of the apportionment, that correction, along with corrections of any non-substantive errors, will be processed as part of the next apportionment.

#### AMENDMENTS TO PRIOR YEAR FORMS SUBMITTED

Legislation enacted July 1, 1989, limited adjustments to one prior fiscal year only (Assembly Bill 198, Chapter 83/Statutes 1989). Adjustments for periods prior to the last fiscal year must be accompanied by documentation from the district's independent auditor confirming the correction.
