SUBJECT: Data Collection for Apportionment of Forest Reserve Funds, Fiscal Year 2020-21

Education Code Section 2300 requires county offices of education to apportion Forest Reserve funds received under any act of Congress from the United States Government to school districts within or adjacent to United States Forest Reserves located in each county. Your district is eligible to receive Forest Reserve funds if it has territory within or adjacent to the Los Angeles National Forest Reserve in the Los Angeles County, and is educating students who reside within it.

Funds received are apportioned based on enrollment of pupils residing within the Los Angeles National Forest Reserve in the Los Angeles County on the last day of the sixth school month, and who are attending school in your district.

Please return the attached Enrollment Report and a listing (in Excel) of the names and addresses of all pupils enrolled in your district on the last day of the sixth school month of 2020-21, who reside within the Los Angeles National Forest Reserve. **The completed report and listing are due no later than April 15, 2021, and must be submitted via email to Martinez_Alyssa@lacoedu.edu.**
