SUBJECT: Instructions for Wave 3 Advantage Financial (FIN) Users and Reminder for Wave 1

and 2 Agencies - Processing Requests for Global Vendor Set Up

The current Global Vendor designation has changed with the implementation of the BEST Advantage – Financial (FIN) system. Agencies can now create or modify Global Vendors within the system and the requests will now be routed for approval through the online workflow approval process. Global Vendors will be exempt from the Los Angeles County Office of Education (LACOE) School Financial Services (SFS) Commercial Claims' review as long as the payments are using the following fund/object combination:

When submitting back-up documentation for Global designation, the support must be attached to the Vendor/Customer Creation (VCC)/Vendor Customer Modification (VCM) documents in FIN. Everything provided will be routed through workflow to the District Voucher Approver (authorized to approve payments in FIN) then to SFS for approval.
