### **Changes in 1099 Processing for Calendar Year 2022**

Starting this calendar year, LACOE will no longer print hard copies of the 1099-MISC/NEC forms. We will provide the districts an electronic copy of the forms which will be uploaded to each agency's folder on the Customer Resource Center (CRC) website. The forms can be downloaded and printed locally at the school district.

As a reminder, LACOE will no longer process 1099s for interfacing agencies. Interface agencies may want to contact their financial systems vendor and inquire if they are able to process their district's 1099s.
