The Los Angeles County Schools Pooled Financing Program (Financing Program) is actively seeking districts that wish to participate in our 2023-24 TRANs issuance. Districts are reminded that pooled financing is the least expensive method for a TRANs issuance. Please see the key dates listed below. Our Financing Program is in its 35th year of offering TRANs, and has issued over \$4.2 billion in short and long-term financing to 73 Los Angeles County School and Community College Districts. TRANs proceeds are invested by the Los Angeles County Treasurer-Tax Collector in the county treasury pool.
