This year the sessions will be focused on retirement reporting for the K-12 public schools and charter schools.

CalSTRS will be covering the following topics during the workshop:

Creditable Service: This course covers the topic of creditable service. You will learn how to recognize the requirements of creditable service, identify service that is creditable, and explain the grandfathering of misreported service.

Creditable Compensation: This course covers the topic of creditable compensation. You will learn the conditions that make compensation creditable, the types of compensation that are reportable, and how to report compensation using the appropriate annualized pay rate.

LACOE strongly recommends that all districts and charter school administrators as well as staff in the Human Resource Services and Payroll departments attend.
