BOARD RESOLUTION

No. 39: 2022-2023

National Child Abuse Prevention Month, April 2023

- Children are some of the most vulnerable members of society. WHEREAS, WHEREAS. communities must make every effort to promote programs and activities that create strong and thriving children and families; and children deserve to grow up in a safe and nurturing environment free from abuse WHEREAS. and neglect; and child abuse and neglect are serious concerns affecting every segment of our WHEREAS, community, and finding solutions requires input and action from everyone; and public health emergencies, including the COVID-19 pandemic, increase the risk WHEREAS, for child abuse and neglect because of increased stressors and loss of financial and social supports, according to the Centers for Disease Control and Prevention; and child abuse can have long-term psychological, emotional and physical effects that WHEREAS, have lasting consequences for the victims; and WHEREAS, Over the long term, children who are abused or neglected are also at increased risk for experiencing future violence victimization and perpetration, substance abuse, sexually transmitted infections, delayed brain development, lower educational attainment, and limited employment opportunities; and LACOE recognizes that teachers and other school staff are in an optimal position WHEREAS, to prevent, identify, and assist victims of child abuse and neglect because of their frequent contact with students; and
- WHEREAS, LACOE and the LA County Department of Children and Family Services (DCFS) collaborate to provide training, guidance and awareness opportunities regarding child abuse prevention information to educators; and
- WHEREAS, LACOE recognizes that providing linkages to community-based prevention services and access to resources to families whose children may be at risk of child abuse or neglect is critical; and
- WHEREAS, child abuse prevention remains the best defense for our children and families and effective prevention activities succeed because of the partnerships created between child welfare professionals, education, health, community- and faith-based organizations, business, law enforcement agencies and families; and
- WHEREAS, we acknowledge that we must work together as a community to increase awareness about child abuse and contribute to promoting the social and emotional wellbeing of children and families in a safe, stable and nurturing environment; and

NOW, THEREFORE, BE IT RESOLVED that the Los Angeles County Board of Education and the Los Angeles County Superintendent of Schools declare April as National Child Abuse Prevention Month and urge communities to recognize this month by working together to support child abuse prevention programs and activities.
