AB 540	N/A	AB 540 is a status that allows students to be considered a California resident for purposes of paying in-state tuition (instead of out-of-state tuition, which is much higher) . To qualify for AB 540, students must submit an AB 540 Affidavit indicating that they have: • 3 years of coursework and • 3 years of attendance at a combination of California elementary school, middle school, high school, adult school, or community college https://www.csac.ca.gov/post/california-nonresident-tuition-exemption
Chafee App	Y, N, No Data	The California Chafee Grant for Foster Youth (Chafee Grant) awards up to \$5,000 a year to eligible foster youth. The Chafee Grant may be used at any eligible California college or university, or career or technical school. Students attending schools in other states may also qualify. A student's receipt of a Chafee Grant award shall not exceed five years (consecutive or cumulative). Payment on an eligible California Chafee Grant Award is not guaranteed. Funding is limited. Payments are made on a first-come first-served basis. Students must: • Be a current or former foster youth who was a ward of the court, living in foster care, between the ages of 16 and 18. • Not have reached their 26th birthday as of July 1st of the award year. • Be enrolled in an eligible vocational school or college courses at least half-time. • Be making satisfactory academic progress.
